The BODYART School reserves the right to add additional modules to extend a BODYART License.

#### License Renewal Procedure

Participation in any of the above listed BODYART modules will extend the BODYART license term by a further two years (from the date of the education). In this way your license moves dynamically with you whenever you complete an education. An example: The training took place on February 1st and 2nd, 2020, the license expiry date becomes February 2nd, 2022 etc. Each BODYART Instructor can either choose to participate in a number of modules of interest and the license will be extended accordingly by a further two years. Alternatively, the Instructor can make full use of the two year license period and choose a module towards the end of the renewal period. If training is more in focus, it is likely that participation in modules will be made regardless of the license term.

To become a BODYART Elite Instructor, the following Level 2 modules and requirements are necessary:

With successful completion of the above the modules as well as sufficient teaching experience, the BODYART Instructor can register for the Elite Instructor examination. We highly recommend participation in the BODYART Improvement Module, which has been specifically designed to prepare Instructors for the Elite Examination, and is scheduled shortly before the exam takes place. . The successful completion of the Elite Exam is recognised as valid for license extension.

### **Exceptional rule**

In case of pregnancy it is possible to apply to pause your license for a period of time. This is permitted during the first 5 months of the pregnancy. The pause has a maximum duration of 12 months from the date your license expires. Any pause of the license must be confirmed in writing by the BODYART School.hool.

### **Legal Notice**

It is not permitted to offer training labelled "BODYART" or use the label "BODYART Instructor" without the successful completion of the BODYART Level 1 Education. While taking part in the Level 1 Education, it is not permitted to use the label "BODYART Instructor". For training purposes, it is permitted to teach BODYART lessons on condition that these are clearly identified as practice lessons and that no money is taken from the participants. BODYART Training can only be listed in the training schedule of a studio if the Instructor is a licensed BODYART Instructor.
